Stallion Service Contract

for

Donnermeyer

(De Niro - Weltmeyer - Romadour II)

This agreement is made _____ (Date), between the stallion owner, Sharon Enderlein, dba Brookstone Farms, and the mare owner, _____. They agree to breed the mare, _____, registered with _____ (registry and number), to the Swedish Warmblood stallion, Donnermeyer, during the 2010 Breeding season. Mare owner agrees to the following fees:

1. Nonrefundable booking fee of \$150.00 USD, due with the signing of this contract.
2. A service fee of \$700.00 USD, which is the balance of the \$1000.00 USD stud fee, minus the \$150.00 USD discount offered if booked by March 31, 2010; payable prior to mare being serviced, or semen being shipped.
3. Mare care of \$10 USD per day, and any other expenses (i.e. farrier, vet, special medications) incurred during mare's stay, payable upon mare leaving farm. Brookstone Farms reserves the right to place mare in a stall, pasture or paddock, or a combination of these; mare owner is responsible for supplying mare's feed.
4. A collection fee of \$200 USD is due prior to each shipment of cooled semen.
5. A container and shipping fee of \$125 USD is due prior to each shipment of cooled semen, using FedEx Overnight (\$50 USD surcharge for Saturday delivery, First Overnight, or courier). Shipping fee is subject to increase, with increasing FedEx tariffs.

Donnermeyer is a registered Swedish Warmblood stallion, approved for breeding with the American Warmblood Society (AWS). It is the mare owner's responsibility to verify the foal's eligibility for registration, and to fulfill the requirements of that registry. Stallion owner agrees to provide mare owner with a Covering certificate, as proof of this breeding.

Brookstone Farms reserves the right to determine if the mare will safely stand for a live cover. If she is determined not to be safe, or for any other reason, will not stand for live cover, the mare owner agrees to have Brookstone Farms arrange to have the mare artificially inseminated, and will assume the cost of a collection fee of \$200 USD, and any fees associated with having the mare artificially inseminated. Prior to breeding, the mare owner agrees to provide the following:

- 1. Documentation of a clean culture and cytology, performed by a licensed veterinarian.
- 2. Documentation of Rhinopneumonitis, Influenza, and Strangles vaccines, given within 2 months of mares coming to farm for live-cover.
- 3. A current negative Coggins Report, for mares coming to farm for live-cover.

The mare owner also agrees that their mare has had Eastern & Western Encephalomyelitis and Tetanus vaccines, within the last year.

Brookstone Farms offers a Live Foal Guarantee (LFG); should the mare not deliver a live foal, as a result of this breeding, the mare may be re-bred the following year at no additional stud fee (mare care, collection and shipping fees still apply). If mare owner wishes to use another mare as a substitute, in the case of breeding unsoundness or the death of their mare, they may do so with the stallion owner’s approval. In order for the mare owner to take advantage of the LFG, they agree to notify the stallion owner within 10 days of discovery, and provide written proof of the fact by a licensed veterinarian.

Brookstone Farms, and Don and Sharon Enderlein, shall not be held liable for the death, illness, and/or injury of the mare, while she is at Brookstone Farms. In turn, Brookstone Farms agrees to give the same care, to this mare, as it does with it’s own horses.

Mare owner agrees to give mare proper care during her pregnancy, to insure a healthy foal, including; vaccinating with Rhinopneumonitis (Pneumabort) at 5, 7, & 9 months of her pregnancy, implementing an acceptable deworming schedule, feeding a proper diet (vitamins & 12% - 14% protein for last trimester), and keeping the mare current on her regular vaccinations (EWT & Flu). If this is not done, and mare fails to produce a live foal, the Live Foal Guarantee is null and void.
